What is Teen Court?

Youth courts (also called teen, peer, and student courts) are programs in which youth are sentenced by their peers for minor crimes, offenses, and/or violations.

Youth court programs ae intended to offer an alternative to the traditional juvenile justice system and school disciplinary proceedings.

How Does Teen Court Work?

Youth volunteers serve as judges.

Defendants are questioned by the teen defense and prosecution attorneys to determine the circumstances of the offense. After careful consideration of the facts and circumstances, the teen jury determines a fair and constructive sentence, which may include community service and participation in future teen court sessions, counseling, attending educational programs, writing essays, and letters of apology to victim.

The goal of Teen Court is to cultivate academic improvements, problem-solving capabilities, conflict resolution skills, positive peer-on-peer contact, and positive youth-on-professional contact. Teen Court aims to empower all participants with the ability to make good life decisions, decrease juvenile delinquency and recidivism while increasing positive behavior, community awareness, and a sense of safer communities.

Why Teen Court?

The philosophy of Teen Court is to use peer pressure as a positive force that holds the teen offenders accountable for their actions. In Teen Court, the emphasis is on restorative justice, seeking to repair the harm done to the victim and community.



What is the Participation Criteria?

- Must be a first-time misdemeanor offense
- Offender must admit involvement/guilt
- Offender must be between ages 12 and 17 at the time of the offense
- Offender and parent must agree to participate in the program
